A Message from our Association President

Amendment Update

The next few weeks are an important time for the Turnberry Homeowners Association. We have until October 17th to reach 146 votes for approval of the Amendments to the Articles of Incorporation and to the Bylaws. As of October 2nd, these are the numbers.

Change in Articles - 110 approved; 13 disapproved Change in Bylaws - 109 approved; 12 disapproved

The Board of Directors proposal <u>removes the restriction of an officer of the Board from holding</u> <u>more than 5 proxy votes</u>. The sole purpose of designating a proxy is to establish the attendance quorum at the Annual Meeting in November. People who cannot attend the meeting in person designate a proxy who can be counted to meet the 30% membership requirement of 66 members present to hold the annual meeting.

Last November, the Turnberry HOA was unable to hold its Annual Meeting after we failed to achieve a quorum of the membership because that restriction had been discovered. Voting YES for both amendments makes it possible to hold Annual Meetings without a scramble to find proxies for those who cannot attend the meeting in person. Please vote YES before Oct.17th if you have not already done so.

Board of Directors Election

Because there was no Annual Meeting last year, all 5 Board positions are up for election this November. As of this time, 4 current Board Members have indicated that they will not run for reelection. Those who wish to run, should plan, if possible, to attend the October 17th Fall Social (details below) at which candidates will have the opportunity to introduce themselves to Homeowners and give a brief (3 minutes or so) background about themselves.

This is a great opportunity to socialize with neighbors and friends in the Turnberry Community as well as meet with the candidates for next year's Board of Directors. I hope to see you there.

This & That

- > The semi-annual Turnberry Garage Sale is scheduled for October 26th from 8am to 2 pm
- The BOD approved a new application form for Estate Sales. It should make its way to the Turnberry Website soon, but until then contact May Management if you need one.
- We are scheduling our fall power washing for the sidewalks between the pool and Sandlake Road and the sidewalk at the entrance. It's been a long summer with plenty of dust and debris from storms and road work. If you haven't power washed your sidewalk and driveway area, the fall is a good time to plan to do it or have it done.
- There have been a few gator sightings in the ponds around Turnberry in the last month or two. In each case, Northwest Masters Association contacts the Florida Wildlife Commission (FWC) which makes the determination on whether or not to remove the alligator from the pond. FWC only removes the alligator if it becomes aggressive; otherwise, the alligator is allowed to remain in its natural habitat.
- Budget work for 2025 continues. At this point, the Board anticipates Turnberry HOA fees will go up by \$30 a quarter from \$250 to \$280. We have had some big-ticket items and while the Reserve Fund has handled the bulk of the work, we will need to begin the process of replenishing the Fund for future projects.

Last Thoughts

This is my last newsletter as President of the Turnberry Board of Directors. I have had a tremendous learning experience, but I will admit it was much more work than I anticipated. Nevertheless, it is rewarding to see newly paved roads, a new well for irrigation, and plans in place to resurface the pool and remediate sidewalk imperfections. I was fortunate to step in to a situation where adequate planning for these items had been undertaken and resources were available to get the work done. As Turnberry continues to age, it will continue to require leadership to plan in advance. For those of you out there who have good administrative skills and a willingness to get things done, please consider running for the Board of Directors. Turnberry is a wonderful community and a beautiful place to live; it takes the efforts of all of us working together to keep it that way.
